- Protections in public records requests
- Jane/John Doe filing protections
- Comprehensive victims rights in criminal proceedings
- Campus responses to sexual assault, stalking and dating violence
- Mandatory and ongoing prosecutor and judicial trainings
- Protections of confidential and privileged information and records
- Recognition of technology-based abuse & coercive control
- Whistleblower protections for survivors
- Enforcement mechanism for system failures
- State ombuds for survivors
- Survivor-led systems oversight
- Stronger protections and rights for young adult survivors
- Coverage of all counseling and medical costs
