The ultimate goal of the Whole Washington organization is National Improved Medicare for All at the federal level. Whole Washington fully supports and participates in efforts to pass national, single payer legislation, and we enthusiastically endorse the Medicare for All Act of 2021. # In Case You Missed Our Last Meeting...

Our endorsements continued at our August meeting on Zoom. Two of our endorsed candidates from the June meeting failed to advance to the November Election: Brianna Thomas running for Seattle Council, and Pete Holmes seeking another term as Seattle Attorney. Both finished third in their respective races.

Additionally in June, we failed to reach consensus and put our stamp on the Seattle Mayoral race and gave no endorsement for the Primary, although Lorena González received the most support in June. González and Bruce Harrell are both headed into the General Election, and in a rematch, González received our endorsement with over 76% of the vote.

The General Election matchups for Seattle City Attorney and the At -Large Council Position 9 left us with only one choice each. City Attorney candidate Nicole Thomas-Kennedy received our endorsement, as her opponent, Ann Davison is a Republican. Similarly, Sara Nelson was the only person eligible to be nominated as the other candidate, Nikkita Oliver, does not identify as a Democrat. Although Nelson was nominated, she did not obtain our endorsement.

We also endorsed Jennifer Fichamba for Highline School Director for Position 2.

Prior to the meeting we had a well-attended mini forum on the proposed Seattle Charter Amendment 29, which will be on the fall

ballot. It was drafted by Compassion Seattle, a group made up of civic leaders who initiated a paid signature gathering campaign earlier this summer. The amendment lays out a plan to solve the homeless crisis in the city, and the region. It has opposition from a group called House Our Neighbors, the ACLU, and other groups. The members voted to endorse a REJECT position.

Brandon Hersey spoke to his re-election campaign for Seattle School Board in District 7. He is filling out the remainder of the term of Betty Patu, who resigned in 2019. He will be seeking our endorsement. Although it is not our district, we will be able to vote in that race in November.

The Speak-Up-Survey was regarding meeting in person, and the likelihood members would be attending any of the new meeting spots listed on the survey or continue to use Zoom.

Treasurer Julie Whitaker presented a revised budget to better track our expenses, we have shifted to a fiscal year ending in April. The modifications will better fit our reality. Our membership now stands at 551, a result of the contest between 34th officials Dow Constantine and Joe Nguyen for County Executive.

All four of our Burien City Council made it through the Primary, all coming in first except for Hugo Garcia, who trailed in second place in his race for Position 1.

Changes to our campaign contribution budget distribution approved in June were needed as we did not endorse a new person in the Seattle City Council Position 9 race. We voted to evenly split that \$600 between the 4 Burien City Council candidates. We also gave \$150 to Jennifer Fichamba originally slated for a King County Superior Court race, as there was confusion over whether we could give to judicial candidates. There is a reserve of \$200 for future endorsees.

In other business we passed two initiatives. The <u>Resolution in</u> <u>Support of the Protecting the Right to Organize ("PRO") Act</u>. The PRO Act was passed in the U.S. House and drew substantial Senate support. It would strengthen the ability to organize, end Right-to-Work laws and provide other labor protections. The <u>Resolution on Sustainable Mobility</u> calls for 100% of the new carbon pricing revenue goes toward funding sustainable transportation methods.

# **Resolution in Support of a Select Committee for Climate in the Seattle City Council**

**Whereas,** 70% of greenhouse gas emissions (GHGs) come from cities\* and Seattle is the largest city in the state; it is thus essential that Seattle reach its GHG reduction goals if King County and Washington State are to achieve their goals.

**Whereas**, citizens of Seattle need to see that the goals of the City's Green New Deal are being addressed in a systematic, transparent and effective way, with special consideration of underserved neighborhoods.

Whereas, achieving Seattle's climate goals will require legislation that is currently overseen by at least six different council committees, and six committees working separately cannot produce a coherent set of agreed-upon, city-wide goals, priorities and strategies for action.

Whereas, as a committee of the whole Council, a Select Committee will enable the establishment of consistent city-wide, multisector priorities for goals, strategies, actions, council staffing and work plans, and it would enable the Council to assess city-wide progress on GHG emission reductions that cut across multiple sectors in a way that no single standing Committee could accomplish, and

**Whereas,** since citizen participation is absolutely essential to the achievement of the City's climate goals, a Select Committee would enable citizens to understand, track and hold the Council accountable for achievement of those goals, and it would highlight, in a way that only a committee of the whole could, the central priority the City is giving to climate change.

**Now, therefore, be it resolved** that the 34<sup>th</sup> Legislative District Democrats request that the Seattle City Council immediately form a Select Committee on Climate Change and Environmental Justice.

**Therefore, be it further resolved** that the Select Committee shall ensure agreement on priority strategies to achieve the City's GHG reduction goals, actions needed to accomplish the agreed City-initiated strategies, the schedule and budget allocations for implementation of essential actions, and a detailed plan for monitoring its success.

# **Resolution Supporting Whole Washington Health Trust**

WHEREAS Article 25 of the United Nations Universal Declaration of Human Rights sets forth that "Everyone has the right to a standard of living adequate for the health and well-being of himself and of his family, including food, clothing, housing and medical care and necessary social services, and the right to security in the event of unemployment, sickness, disability, widowhood, old age or other lack of livelihood in circumstances beyond his control" establishes a fundamental right to healthcare<sup>1</sup>;

WHEREAS, in the Declaration of Independence, a foundational document of the Constitution of the United States, declares the responsibility of government to protect certain unalienable rights which include but are not limited to the preservation of "Life, Liberty, and the pursuit of Happiness" we conclude that healthcare is a prerequisite for the latter, and as such is indeed a human right;

WHEREAS in Washington State, 498,000 have no health coverage and even more residents are underinsured, and lives could be saved by ensuring access to healthcare;

WHEREAS COVID-19 demonstrates that healthcare should not be tied to employment;

**WHEREAS** the 2020 platform of the Washington State Democratic Party affirms that "healthcare is a basic human right," and that "An affordable universal single-payer system is essential to provide the most equitable and effective health care, serving both individual and public health needs<sup>2</sup>" and;

**WHEREAS** the 2020 State Democratic Party Platform calls on "Washington State to establish a single-payer system for Washington residents until such time as a single-payer system is enacted nationally;"

WHEREAS a single-payer resolution was adopted by the Washington State Democratic Central Committee in April of 2017<sup>3</sup>;

**WHEREAS** people of color, people with disabilities, and low income people are the most likely to lack affordable, comprehensive healthcare<sup>4</sup>;

WHEREAS Whole Washington has crafted a bill<sup>5</sup> (SB 5204), introduced by Senator Hasegawa and 6 other cosponsors, guaranteeing universal healthcare to all Washingtonians, with a funding mechanism devised by a noted economist, reviewed by the Department of Revenue and the Employment Securities Department, which demonstrates that Washington state residents will save billions of dollars annually when universal healthcare is implemented;

THEREFORE, BE IT RESOLVED THAT the 34th District Democrats endorse the Whole Washington universal healthcare bill;

**THEREFORE, BE IT FINALLY RESOLVED THAT** the upon adoption of this resolution, it be sent to the *Seattle Times*, and all state representatives in the Washington Legislature.

The talk featured the history of Gerrymandering and its uses for political control, and on a few occasions to achieve racial equity. McCaffree's grandmother was Mary Ellen McCaffree, a state representative who was a pioneer in redistricting in Washington State. Alison is founding director of the non-profit organization <u>Politics</u> of the <u>Possible</u>, which is based on the writings and philosophy of her grandmother. She also represents the League of Women Voters in redistricting matters.

# What The Infrastructure Investment and Jobs Act will Deliver for Washington

**From The Washington State Democrats** - President Biden and Vice President Harris support the Senate's passage of the Infrastructure Investment and Jobs Act, the largest long-term investment in our infrastructure and competitiveness in nearly a century. **The need for action in Washington is clear and recently released state-level data demonstrates that the Infrastructure Investment and Jobs Act will deliver for Washington**. For decades, infrastructure in Washington has suffered from a systemic lack of investment. In fact, the American Society of Civil Engineers gave Washington a **C grade** on its infrastructure report card. The historic Infrastructure Investment and Jobs Act will make life better for millions of Washington residents, create a generation of good-paying union jobs and economic growth, and position the United States to win the 21st century. Specifically, the Infrastructure Investment and Jobs Act will:

- Repair and rebuild our roads and bridges with a focus on climate change mitigation, resilience, equity, and safety for all users, including cyclists and pedestrians. In Washington there are 416 bridges and over 5,469 miles of highway in poor condition. Since 2011, commute times have increased by 12.7% in Washington and on average, each driver pays \$659 per year in costs due to driving on roads in need of repair. The Bipartisan Infrastructure Framework will devote more than \$312 billion to transform our nation's transportation infrastructure and make it more resilient, including \$110 billion for roads, bridges, and major projects. The Bipartisan Infrastructure Framework is the single largest dedicated bridge investment since the construction of the interstate highway system. Based on formula funding alone, Washington would expect to receive \$4.7 billion for federal-aid highway apportioned programs and \$605 million for bridge replacement and repairs under the Infrastructure Investment and Jobs Act over five years1. Washington can also compete for the \$12.5 billion Bridge Investment Program for economically significant bridges and nearly \$16 billion of national funding in the bill dedicated for major projects that will deliver substantial economic benefits to communities.
- Improve healthy, sustainable transportation options for millions of Americans. Washingtonians who take public transportation spend an extra 72.9% of their time commuting and non-White households are 1.7 times more likely to commute via public transportation. 17% of trains and other transit vehicles in the state are past useful life. Based on formula funding alone, Washington would expect to receive \$1.79 billion over five years under the Infrastructure Investment and Jobs Act to improve public transportation options across the state2.

- Build a network of EV chargers to facilitate long-distance travel and provide convenient charging options. The U.S. market share of plug-in electric vehicle (EV) sales is only one-third the size of the Chinese EV market. The President believes that must change. The bill invests \$7.5 billion to build out the first-ever national network of EV chargers in the United States and is a critical element in the Biden-Harris Administration's plan to accelerate the adoption of EVs to address the climate crisis and support domestic manufacturing jobs. Under the Infrastructure Investment and Jobs Act, Washington would expect to receive \$71 million over five years to support the expansion of an EV charging network in the state3. Washington will also have the opportunity to apply for the \$2.5 billion in grant funding dedicated to EV charging in the bill.
- Help connect every American to reliable high-speed internet. 8.5% of Washingtonians live in areas where, under the FCC's benchmark, there is no broadband infrastructure. Even where infrastructure is available, broadband may be too expensive to be within reach. 8.8% of Washington households do not have an internet subscription. Under the Infrastructure Investment and Jobs Act, Washington will receive a minimum allocation of \$100 million to help provide broadband coverage across the state, including providing access to the at least 241,000 Washingtonians who currently lack it. And, under the Infrastructure Investment and Jobs Act, 1,409,000 or 19% of people in Washington will be eligible for the Affordability Connectivity Benefit, which will help low-income families afford internet access.

Over the coming days and weeks, we will expect to receive additional data on the impact of the Infrastructure Investment and Jobs Act in Washington.

# **KC** Democrats to Consider the Endorsement of Non-Democrats

On August 31st, the King County Democrats will be voting on a motion to change their rules to allow for the endorsement of candidates who are not Democrats. This is an issue that has been simmering for several years. Progressives such as Nikkita Oliver in Seattle and Cydney Moore in Burien have drawn interest from Democrats, but have been ineligible for party endorsement due to their preference to not be known as Democrats.

As this debate is taken up, State Chair Tina Podlodowski has reminded local organizations that they will be sanctioned if they supply NGP-VAN access to non-Democrats, nor would will they be allowed to include them in our campaign literature or as part of canvassing. However, if Democrats do endorse non-Democrats they may attend that candidate's events.
