## December Service Project

Due to the continued risk of COVID-19, the 34th Democrats have decided to forgo the December End-of-Year Party. Instead, the Executive Board plans to sponsor a service project for Camp Second Chance.

**Camp Second Chance** is a clean and sober homeless encampment providing emergency shelter for up to 50 people in tiny homes. The current population is about 53.

The camp is managed by its residents in partnership with the Low Income Housing Institute (LIHI). Camp Second Chance is one of ten encampments authorized and funded by the City of Seattle's Human Services Department as part of the City's emergency response to homelessness.

**We ask members, PCOs and board members to take part in the way that you are able. This project shows the community our Democratic values.**

When you contribute to Camp Second Chance, you are helping to provide bedding, clothing, food, and light – the fundamentals of stable human life. The City provides the infrastructure for the camp such as utilities, and basic sanitation and kitchen supplies – but everything else is the responsibility of the camp itself. The camp leadership distributes resources fairly and carefully to those people who are most in need.

Your material support enables something even more important: a sense of community. To be homeless is to be alone, isolated, cut off from human relationships. The community of the camp provides a sense of belonging, as well as the responsibility to live and work with other people. It's a point of reentry into society, a refuge from chaos, and an anchor in a turbulent world.

## In Case You Missed Our Last Meeting...

Chair **Carla Rogers** began the meeting with a bit of a rant. She was worried that membership participation was sliding. There has been a lack of turnout at some of our campaign events, as well as for attendance to our meetings and special programs. She urged us to “find a place” in our organization and get engaged. We will soon be heading into 2022 with US Senate race with House members to re-elect...with 2024 looming. She gave a shout-out to the state party, which is currently working to fend off Arizona-style “audits” of the 2020 election...[Click HERE to learn more.](#)

The Speak-Up Survey of the month focused on the Holiday Party. There was an online questionnaire, but there was also a pop-up poll during the meeting. The sentiment of those attending was to hold the meeting virtually and saving the Hall rental fee.

2nd Vice Chair and LAC Committee Chair **Jordan Crawley** and **Janine Anzalota**, State Party Committeeperson, have stepped down from their duties, opening up 3 positions on the Executive Board that will need to be filled. Chair Rogers is seeking members who wish to apply for these spots. A new State Committeeperson will have to identify as female, or non-binary. The 2nd Vice Chair position has no gender requirement. Members are also being sought to help with the annual awards this year and with Bylaws and Endorsements next year.

**Nick Bonazza** introduced two new Burien PCOs for appointment just in time for the election. **Nancy Kick** is in BUR 34-1057, and **Sam Mendes** lives in BUR 34-1059. The past weekend Sam had won a pair of Sounders tickets donated by Hugo Garcia as part of an incentive to get folks to turn out in Burien for a GOTV event.

Nick reported that this year for the first time the 34th printed separate sample ballots for Burien, with Spanish, specific to what's on the ballot for that city. These races are tight, with disinformation being spread against our candidates as well as their signs being defaced and stolen. There will be GOTV events going on every Saturday until the election in Burien, and one in West Seattle.

**Vivian Song Maritz** and **Laura Marie Rivera** spoke to us about their campaigns, they are both running for Seattle School Board Director for District 4. We are unable to endorse either, as that district does not overlap into the 34th.

Special Guest former King County Prosecutor **Stephan Thomas** gave a lively presentation on recruiting progressive prosecutors,

"The Most Powerful Elected Officials Never Held Accountable." They wield this power through their discretion on charging/not charging those arrested for crimes. Thomas says: "Police officers take you to jail, prosecutors send you to prison". Prosecutors are the arbitrators of our values...which crimes are important, and which neighborhoods to concentrate on...and he wonders why we in this area have been electing Republicans as prosecutors. Dan Satterberg was a Republican for years before he switched parties, as was Norm Maleng before him.

Thomas talked at length and in freeform about his background. His mother was active in Jesse Jackson's Rainbow Coalition in Chicago. He presented his "street credentials" and spoke about the War on Drugs and the over-reaction to crime in the 1990's. Then he relayed his experience as a prosecutor. He says we must have a conversation on prosecution, such as our current choice for Seattle Attorney, what could be framed as a choice between "abolition and a return to the '90's".

He promoted the organization he helped found, **Prosecutors Accountable to the People**. Organized by current and former prosecutors, it is a "coalition of individuals impacted by the criminal justice system, faith leaders, laborers, and voters" whose goal it is to hold prosecutors accountable "to implement community safety strategies that build healthy, safe, and thriving communities". We had a balance of \$500 remaining in our Campaign contribution budget. We voted to give \$100 each to Seattle School Board candidate **Brandon Hersey**, Burien City Council candidates **Hugo Garcia**, **Sarah Moore**, and **Krystal Marx**, and to the **Highline Schools levy**.

Carla thanked those who provided testimony to the redistricting commission, particularly **Bunny Hatcher** who gave us a rundown on possible boundary changes for the 34th LD and the 7th CD, citing the maps of the 4 commissioners. We will be experiencing disruption starting January, as we gain and lose PCOs and territory.

We approved **Aaron Garcia** to take over the position of KCDCC Alternate.

## Homelessness in the Native American Community

Prior to the meeting there was a special program on homelessness in Seattle, focusing on our Native American population and the difficulties many have.

Derrick Belgrade, Executive Director of the Chief Seattle Club spoke of his organization He is an enrolled member of the Confederated Tribes of Siletz Indians of Oregon, and also Chippewa-Cree from Rocky Boy Montana.

Although they only make up 1% of the population, they are 15% of the unhoused, and up to 32% of chronic homeless. Native Americans are the least likely to access mainstream services due to historical conflict with the American society and the US Government... genocide, erasure of their culture, and reneged promises of treaties...all have caused deep resentment and mistrust.

The Chief Seattle Club is designed to provide community to Native Americans who may not feel to be a part of the surrounding society. Ironically Seattle, which is named after a local Native chief, has less "Native space" compared to other cities, such as Vancouver which is actually named for a European explorer.

The Chief Seattle Club historically has been a drop-in day shelter, a place to get food, shower, wash clothes and rest in a place that provides a sense of community and belonging for the chronic homeless. They also have 2 shelter locations. The club uses a holistic approach that attempts to keep in balance "Four quadrants" of a healthy person: Physical, Mental, Emotional, and Spiritual...with relevant cultural programs. They will soon have long-term housing, and will be opening a café, which will double as a job training opportunity.

# Resolution on the Recovery of Endangered Salmon, Steelhead and Southern Resident Orcas

**WHEREAS**, between 1991 and 1999, thirteen stocks of Columbia/Snake River salmon and steelhead were listed as threatened or endangered under the Endangered Species Act, including Snake River sockeye, steelhead and spring, summer and fall chinook; and

**WHEREAS**, the population of Southern Resident orcas, designated as an endangered species in 2005, has declined from 98 individuals in 1995 to just 74 today, with lack of chinook salmon for food a central cause of the decline; and

**WHEREAS**, over the past two decades, six federal agency salmon recovery plans, and the expenditure of \$17 billion have left the listed stocks of Columbia Basin salmonids closer to being on a track to extinction than on a path to recovery, and Southern Resident orca populations in continuing decline; and

**WHEREAS**, the Northwest can replace the power generated by the four lower Snake River dams with a combination of new wind, solar, and demand-side resources (energy efficiency, demand response, and energy storage) that are all achievable in the next ten years; and improved alternatives to the current irrigation infrastructure and barge transportation practices can be developed, and

**WHEREAS**, resolutions from the Affiliated Tribes of Northwest Indians and from the National Congress of American Indians have emphatically called for breaching the lower Snake River dams, in order to honor the U.S. government's obligations under treaties with Northwest Tribes; and

**WHEREAS**, Senator Patty Murray and Governor Jay Inslee have committed to working "...with our Northwest Tribes, states, and all the communities that rely on the river system to achieve a solution promptly" and added, "We, too, want action and a resolution that restores salmon runs and works for all the stakeholders and communities...;"

**NOW, THEREFORE, BE IT RESOLVED**, that the 34th Legislative District Democratic Organization recognizes and honors the claims of Northwest Tribes, and applauds the leadership of Senator Murray and Governor Inslee in stepping up to drive a timely resolution of these issues; and

**BE IT FURTHER RESOLVED**, that breaching the four lower Snake River dams, accompanied by investments to meet the needs of stakeholders and communities from the Columbia Basin to the coast, must be the twin cornerstones of any lawful and effective salmon and orca recovery plan; and

**BE IT FINALLY RESOLVED**, that we call on the Biden Administration to work with Northwest Tribes, states, other stakeholders and elected officials to meet the U.S. Government's legal and treaty obligations and to provide robust funding to make all this happen as soon as possible.

# Growth Management Planning Ramps Up!

When I moved to Seattle in 1993, the city initiated their first Growth Management Planning process mandated by the state legislature in 1990. I participated in the Land Management Plan process of National Forests beginning in 1979 while living in Southern California. I felt this was an opportunity to learn about Seattle and meet my neighbors. I attended neighborhood meetings on Capitol Hill and later in 1997, in the Admiral District. I felt it was worth my time to research and meet with my neighbors. Now the state is overseeing the third full GMP to update and make changes for a new fifteen-year plan.

It goes without saying that this is a perfect time to review the State's Growth Management Plan. Washington Office of Financial Management website shows the state's 2021 population 7.7 million adding an increase this year of 61,600 new residents. The 2020 census number shows 7,656,200. Seattle grew by 21.1% with a population of 737,015. (2010 population was 508,660). Washington is one of the fastest growing states in the country. The climate crisis, racism, homeless populations and Covid gives us plenty to consider the impacts and consequences of our planning process.

This plan is how we, as residents, design the future our communities, counties, farmlands, industry, resources, and state lands. The foremost goal of the GMA is public involvement. It is seen as a cooperative process between communities, counties, and the state.
