## **Redistricting Updates**

Will this process ever end? We hope so. Regardless of what you may have heard, the process is not complete and we are not officially through redistricting. The Supreme Court punted the decision to the Legislature by accepting the final maps as is from the committee. This means that we are now awaiting the Legislature to vote on the maps. There are currently open lawsuits pending against the process so this may not be quick. Until this vote is complete in the affirmative, we are business as usual.

Once the vote is complete and assuming it is ratified, we will move into a period of 45 days where we will vote (PCOs) to reorganize or leave the current leadership in place (chair). I estimate doing this vote in March but it could happen as soon as February. None of our current elected board members will be affected by the current maps so this should be simple.

Once that has happened, the new district boundaries and officers will be official.

PCOs in affected precincts will remain PCOs and simply move to their new district (the 33rd). I will connect you all via email to the chair of the 33rd Terri Lindeke. Any incoming PCOs will move into our district as well. We will gain 2 PCOs from Burien (within 5 precincts) and lose 14 of our rockstar Burien PCOs. We are also gaining Georgetown, SODO and a small area of downtown. We do not yet know how many precincts will come from these areas as they are not highly populated.

Please stay tuned as the short session begins on January 10th, there are sure to be updates!

## **Upcoming February Elections**

### Seattle Public Schools Levy Renewals - February 8

We endorsed a YES for these two levies at our November meeting. Seattle voters...watch for your ballot after January 19!

Prop. 1: Educational Programs and Operations levy (EP&O) would replace the expiring EP&O, which was approved by Seattle voters in



2019. This levy funds additional staffing positions, critical programs like Special Education and services that are not fully funded by the state. This levy also provides extracurricular student opportunities like music, band, art and athletics.

Prop. 2: Buildings, Technology, and Academics/Athletics V Capital Levy (BTA V). This six-year levy would replace the expiring Building, Technology, and Academics/Athletics IV Capital Levy (BTA IV), which was approved by Seattle voters in 2016. The levy will fund computers for students, technology for classrooms, technology staff and supports. The levy will also fund repairs to aging buildings and ensure our students have safe, comfortable and healthy school buildings.



## **Pass the Green New Deal WA Coalition Update**

A little more than a year ago the 34th Dems passed a resolution where the district joined local efforts to support the Green New Deal at the Federal Level. See our resolution **HERE.** 

The Coalition has been meeting monthly and you can **check Coalition's website** to review the work that has been accomplished.

For some time the Coalition's efforts has been focused on getting President Biden's Build Back Better legislation passed. However now that it has stalled the Coalition will decide what to do next to win a just transition to clean energy, green jobs and a low carbon, high energy economy. We will discuss whether to work on some or all of the following:

- Increase pressure on Congress to end the filibuster, declare a climate emergency and pass stronger climate protection bills,
- Work on the press, the President and Executive branch to declare an emergency,
- Work with local and state projects to imagine and win Green New Deal type funding and policies.

At our last meeting we developed some thoughts on reasons for hope in 2022. We have all been subjected to hope-destroying statements in the media. The purpose of "too late" predictions" is to create the belief that we cannot solve this problem, that we are in a doom spiral. One of the best things we can do is to counter them by believing we can and will address these crises. We know they will not diminish in 2022 but there is hope to be found as well! Some examples and actions to take include:

- At the International Level during the Glasgow Conference a number of side agreements were made on coal, deforestation, methane fossil fuel subsidies and production. These are described on the Coalition's website along with actions to take.
- At the National Level the Build Back Better bill is still pending and we urge you not to stop sending messages of support to our members of Congress.
- At the State Level there are a number of bills coming up in 2022 that address climate change. Bills will be introduced in January and you can follow their profess and send messages of support.

At the Local Level we have a large number of environmental organizations including our own 34th LD which has an active Environmental Policy Caucus. You can join by contacting Chair Carla Rogers at <a href="mailto:chair@34dems.org">chair@34dems.org</a>.

# **Voting Rights for Released Felons Restored Automatically Starting January 1**

While some other states are actively in the process of restricting voting rights,

Washington continues its efforts to make voting as easy as possible. Washington State residents convicted of felonies will now be able to vote in every election **upon their release from prison - See HB 1078.** 



Previously, a newly-released felon needed to complete conditions of their sentence, including community supervision terms which can last for months...even years. This will greatly assist us as we register new voters this year, eliminating any guesswork as we encounter those formerly incarcerated. The state Department of Corrections estimates that around 20,000 people statewide have their right to vote restored.

Special thanks go to Rep. Tarra Simmons (D-Bremerton), who wrote the bill. She has personal knowledge of the complexities of the old requirements, having herself once spent 30 months in prison.

# Resolution Regarding Non-discriminatory, Medically Comprehensive Healthcare in Washington State.

**Whereas,** many regions in Washington State have limited health care access; that is, with perhaps only one clinic and/or one hospital; and

**Whereas**, mergers and acquisitions in the Washington health care system have led to a near monopoly by certain healthcare institutions and hospitals; and

**Whereas,** some hospital 'ethics committees' may not be educated on dangerous health outcomes that surround denials of LGBTQ, and reproductive healthcare; yet all clinics and health care institutions receive significant amounts of federal and state funding through Medicare/Medicaid reimbursements, <u>and may, therefore, be considered federal contractors</u>; and

**Whereas,** some Washington State healthcare institutions are placing arbitrary limits on legal, medically accepted health procedures, and legally and medically approved reproductive and LGBTQ healthcare procedures; and

Whereas, some hospitals and healthcare institutions across the State are delaying and denying this legally and medically approved reproductive and LGBTQ care, using tactics which discriminate primarily against women, BIPOC communities, low income residents, and the LGBTQ community, thus endangering their mental and physical health, if not their *lives*. These hospitals and healthcare organizations are trafficking in discriminatory actions leading to neglect, cruelty, lack of service, and poor health outcomes; some healthcare organizations also fail to recognize the right of Washington State patients to use the State's "death with dignity" law; and

**Whereas,** some hospitals and healthcare providers are putting *their* discriminatory regulations *above* Washington State laws and regulations and their patients' *well-being*; and

**Whereas,** <u>no</u> Washington State health care institutions should be permitted to engage in healthcare restrictions that are intrinsically discriminatory against any race, sex, or LGBTQ status, and therefore damaging to patients' mental and physical health; and

Whereas, by restricting or eliminating such procedures as family planning and contraceptives, tubal ligations, abortions, vasectomies, IVF treatments, and transgender surgeries, discriminatory health care systems in Washington State force their patients to abide by restrictions that are sexist, misogynistic, and anti-LGBTQ against their will, since in both urban and semi-isolated areas of Washington they may have only one clinic or hospital available to them. These patients are therefore effectively discriminated against, and prohibited from exercising their own rights in terms of their healthcare, and it is a violation of those patients' civil rights.

**Therefore, be it resolved** that <u>all</u> healthcare institutions within the boundaries of Washington State <u>cannot restrict any</u> <u>legal medical procedures when requested by patients</u>. Public policy must protect women in need of reproductive health services, as well as BIPOC and LGBTQ patients, and the medical practitioners who would otherwise be prohibited from providing essential, medically comprehensive, and legal services when in discriminatory healthcare settings;

Therefore, be it finally resolved that It should fall to the Washington State Department of Health to ensure that <u>all</u> healthcare systems in Washington State, from this time forward, align themselves with best medical practices and best evidentiary outcomes, and that <u>all procedures legal under Washington State law therefore be offered to patients.</u>

No Washington State healthcare provider, or hospital, should be allowed to discriminate in terms of health care services to their patients, <u>whoever</u> those patients are. <u>Everyone</u> deserves medically comprehensive, legal, quality health care, but not everyone is receiving it at this time.

Note: In the event that this Resolution affects religious health care institutions,

Article 1 of the <u>Bill of Rights</u> recognizes that the United States encompasses a <u>multitude</u> of religions and beliefs, all of which may have differing definitions of 'morality', differing definitions of Scripture, and entirely different modes of worship. Providing and delivering non-discriminatory, medically comprehensive, and legal health care, should be defined and enforced only by the State of Washington.

## Whole Washington to Begin New Universal Health Care Initiative Effort



Roxanne Thayer is calling out to all in the 34th LD interested in seeing universal healthcare in Washington State. Whole Washington will be giving a presentation and short video followed by a Q&A session at our February 9th meeting. Andre Stackhouse and 34th's own Jen Nye will officiate.

Whole Washington is working towards an initiative that will collect signatures between April and December, 2022. They are looking for "Signature Captains" and also others who are willing to collect signatures. The presentation will help people become more familiar with the work of Whole Washington, and build awareness of their new initiative drive.

In preparation for this program, Roxanne suggests reading a confessional by Wendell Potter. Potter is a former vice president of Cigna who became a whistleblower against the health insurance industry. He serves as president of the Center for Health and Democracy, @wendellpotter.

In his article Potter relates his part in spreading disinformation about the Canadian healthcare system to the media and politicians. These untruths were instrumental in killing any sort of public option in Obamacare. His August 2020 piece originally appeared in a Washington Post article **HERE**. ### The health care scare

## I sold Americans a lie about Canadian medicine. Now we're paying the price.

By Wendell Potter

In my prior life as an insurance executive, it was my job to deceive Americans about their health care. I misled people to protect profits. In fact, one of my major objectives, as a corporate propagandist, was to do my part to "enhance shareholder value." That work contributed directly to a climate in which fewer people are insured, which has shaped our nation's struggle against the coronavirus, a condition that we can fight only if everyone is willing and able to get medical treatment. Had spokesmen like me not been paid to obscure important truths about the differences between the U.S. and Canadian health-care systems, tens of thousands of Americans who have died during the pandemic might still be alive.

In 2007, I was working as vice president of corporate communications for Cigna. That summer, Michael Moore was preparing to release his latest documentary, "Sicko," contrasting American health care with that in other rich countries. (Naturally, we looked terrible.) I spent months meeting secretly with my counterparts at other big insurers to plot our assault on the film, which contained many anecdotes about patients who had been denied coverage for important treatments. One example was 3-year-old Annette Noe. When her parents asked Cigna to pay for two

cochlear implants that would allow her to hear, we agreed to cover only one.

Clearly my colleagues and I would need a robust defense. On a task force for the industry's biggest trade association, America's Health Insurance Plans (AHIP), we talked about how we might make health-care systems in Canada, France, Britain and even Cuba look just as bad as ours. We enlisted APCO Worldwide, a giant PR firm. Agents there worked with AHIP to put together a binder of laminated talking points for company flacks like me to use in news releases and statements to reporters.

Here's an example from one AHIP brief in the binder: "A May 2004 poll found that 87% of Canada's business leaders would support seeking health care outside the government system if they had a pressing medical concern." The source was a 2004 book by Sally Pipes, president of the industry-supported Pacific Research Institute, titled "Miracle Cure: How to Solve America's Health Care Crisis and Why Canada Isn't the Answer." Another bullet point, from the same book, quoted the CEO of the Canadian Association of Radiologists as saying that "the radiology equipment in Canada is so bad that 'without immediate action radiologists will no longer be able to guarantee the reliability and quality of examinations.'"

Much of this runs against the experience of many Americans, especially the millions who take advantage of low pharmaceutical prices in Canada to meet their prescription needs. But there were more specific reasons

to be skeptical of those claims. We didn't know, for example, who conducted that 2004 survey or anything about the sample size or methodology — or even what criteria were used to determine who qualified as a "business leader." We didn't know if the assertion about imaging equipment was based on reliable data or was an opinion. You could easily turn up comparable complaints about outdated equipment at U.S. hospitals.

Nevertheless, I spent much of that year as an industry spokesman, my last after 20 years in the business, spreading AHIP's "information" to journalists and lawmakers to create the impression that our health-care system was far superior to Canada's, which we wanted people to believe was on the verge of collapse. The campaign worked. Stories began to appear in the press that cast the Canadian system in a negative light. And when Democrats began writing what would become the Affordable Care Act in early 2009, they gave no serious consideration to a publicly financed system like Canada's. We succeeded so wildly at defining that idea as radical that Sen. Max Baucus (D-Mont.), then chair of the Senate Finance Committee, had single-payer supporters ejected from a hearing.

Today, the respective responses of Canada and the United States to the coronavirus pandemic prove just how false the ideas I helped spread were. There are more than three times as many coronavirus infections per capita in the United States, and the mortality rate is twice the rate in Canada. And although we now test more people per capita, our northern neighbor had much earlier successes with testing, which helped make a difference throughout the pandemic.

The most effective myth we perpetuated — the industry trots it out whenever major reform is proposed — is that Canadians and people in other single-payer countries have to endure long waits for needed care. Just last year, in a statement submitted to a congressional committee for a hearing on the Medicare for All Act of 2019, AHIP maintained that "patients would pay more to wait longer for worse care" under a single-payer system.

While it's true that Canadians sometimes have to wait weeks or months for elective procedures (knee replacements are often cited), the truth is that they do not have to wait at all for the vast majority of medical services. And, contrary to another myth I used to peddle — that Canadian doctors are flocking to the United States — there are more doctors per 1,000 people in Canada than here. Canadians see their doctors an average of 6.8 times a year, compared with just four times a year in this country.

Most important, no one in Canada is turned away from doctors because of a lack of funds, and Canadians can get tested and treated for the coronavirus without fear of receiving a budget-busting medical bill. That undoubtedly is one of the reasons Canada's covid-19 death rate is so much lower than ours. In America, exorbitant bills are a defining feature of our health-care system. Despite the assurances from President Trump and members of Congress that covid-19 patients will not be charged for testing or treatment, they are on the hook for big bills, according to numerous reports.

That is not the case in Canada, where there are no copays, deductibles or coinsurance for covered benefits. Care is free at the point of service. And those laid off in Canada don't face the worry of losing their health insurance. In the United States, by contrast, more than 40 million have lost their jobs during this pandemic, and millions of them — along with their families — also lost their coverage.

Then there's quality of care. By numerous measures, it is better in Canada. Some examples: Canada has far lower rates than the United States of hospitalizations from preventable causes like diabetes (almost twice as common here) and hypertension (more than eight times as common). And even though Canada spends less than half what we do per capita on health care, life expectancy there is 82 years, compared with 78.6 years in the United States.

When the pandemic reached North America, Canadian hospitals, which operate under annual global budgets — fixed payments typically allocated at the provincial and regional levels to cover operating expenses — were better prepared for the influx of patients than many U.S. hospitals. And Canada ramped up production of personal protective equipment much more quickly than we did.

Of the many regrets I have about what I once did for a living, one of the biggest is slandering Canada's health-care system. If the United States had undertaken a different kind of reform in 2009 (or anytime since), one that didn't rely on private insurance companies that have every incentive to limit what they pay for, we'd be a healthier country today. Living without insurance dramatically increases your chances of dying unnecessarily. Over the past 13 years, tens of thousands of Americans have probably died prematurely because, unlike our neighbors to the north, they either had no coverage or were so inadequately insured that they couldn't afford the care they needed. I live with that horror, and my role in it, every day.
