Early Endorsements - May Meeting

We will hear motions for early endorsements at the April 13th meeting. The only endorsements we will consider include that of US Senator and WA State Secretary of State. The State Party has requested that these 2 endorsements be considered early to allow for maximum influence for the candidates. The King County Democrats also considered these 2 early endorsements in their meeting last month.

Senator Murray, first elected to the U.S. Senate in 1993 is Washington's first female U.S. Senator. She is the Chair of the Senate Health Education Labor Pensions (HELP) committee and serves as Assistant Majority Leader. Her priorities include tackling the climate crisis, affordable health care, universal paid leave, pathway to citizenship, and strengthening voting rights. The endorsement committee believes her progressive values and seniority benefit Washington residents. Find Senator Murray's questionnaire here.

Secretary of State Hobbs was appointed to his position in November 2021 after serving as a Washington State Senator since 2006. He served in the US Army since 1987 and has a background in cyber security. Secretary Hobbs seeks to eliminate the ballot rejection rates for different racial and ethnic groups, enhance cybersecurity, and increase voter registration. Secretary Hobbs is the first Democrat to serve as WA Secretary of State since 1965 despite recent strong candidates. The committee believes that an early endorsement of Secretary Hobbs will increase the chances of keeping this important elected position in Democratic hands. In Case You Missed Our Last Meeting...

Chair **Carla Rogers** opened the meeting with remarks about Ukraine, which is of personal concern to her. Carla's entire technical team for her day job lives and works in Ukraine. She, Ann Martin, and Colleen Hinton attended a rally for plight of that country under attack. We observed a moment of silence to reflect on our role in our democracy and in support of the people of Ukraine.

The short 2022 session in Olympia was to end the day after the meeting, and Carla thanked our legislators for delivering on many of our priorities. She expressed personal gratitude to see the passage of Senate bill 5078 in the face of pressure from gun lobbyists. It prohibits large capacity firearm magazines. Our policy caucuses lobbied for, and helped our understanding of, bills as they made it through the session.

The Membership Survey of the month asked us whether we wish to hold June our endorsement meeting in person or virtually.

The Candidate Spotlight featured **Lisa Manion** who is running for King County Prosecuting Attorney. She has served as the chief of staff at the King County prosecuting attorney's office overseeing a staff of 600 employees, with an annual budget of 80 million dollars. She is especially proud of being a co-founding partner of **Choose 180**, a diversionary program to keep non-violent juveniles out of the court system with mentorship. If elected, Manion would be the first woman and person of color in this position.

Judges seeking our endorsement spoke. **Damon Shadid** is running for re-election to his 3rd term as a Seattle Municipal Court Judge in Position 7. West Seattle resident **Faye Chess** is also seeking our endorsement to retain her Seattle Municipal Judge seat.

We heard from the people behind Initiative 134, which would bring "Approval Voting" to Seattle City elections, <u>Seattle Approves</u>.

Efrain Hudnell and **Logan Bowers** gave a presentation on the concept in which a voter gives votes of approval to any number of their preferred candidates in the primary. The two candidates with the most approval votes would then go on to the general election. This process has been used in two jurisdictions so far, most recently in St. Louis for their mayoral race. This voting method differs from Ranked Choice or Instant Run-off voting in that it retains a primary, which is required by Washington State law, and so would not require statute changes to allow a change to our voting

method locally. Candidates emerging from a large field would have a higher percentage of the vote, which in theory would better represent the will of the electorate.

This initiative is slated to be on the November 8 ballot, provided it receives 26,200 signatures by June. According to the Seattle Times, the campaign accepted \$160,000 last December from the Center for Election Science, a nonprofit national think tank focused on the "approval voting" method, per financial disclosures. Much of this money will be used to hire signature-gatherers.

Gina Topp is planning this year's fundraising event which will be in person on July 14th from 6 to 8 p.m at Arthur's restaurant in the Admiral District. The theme is to be revealed in April. She asked that we reserve tickets online during the meeting, those contributions were to be matched.

Nick Bonazza appointed a new PCO, **Zachary Ricketts** for Seattle precinct 34-3767.

Nick then continued by reading off the names of the PCOs that were just redistricted into the 33rd LD and bid them to continue their work with that organization. He also welcomed new PCOs who were redistricted into the

Souffront and **Sarah Servin** from the 33rd, **Adam Hutchinson** from the 37th, and **Linda Mitchell** who joins us from the 43rd.

All PCOs who remain in the 34th will remain in office until December, However, to complete our redistricting duties, we needed to conduct another officer election, in which we voted to maintain our current roster of officers.

Colleen Hinton ran down the caucus and convention schedule, followed by **Chris Porter** who gave an appeal for diversity in the delegation we send to the state convention. **Rachel Glass** also spoke in support of inclusion of diverse voices to bring issues to the table and crafting our platform. We then voted to approve the membership caucus rules.

Karen Richter and **Steve Butts** listed the events that have been announced that we are planning to take part in. Contact outreach@34dems.org or volunteer@34dems.org. Carla announced the next Popup Social, March 25th at Future Primitive Brewery in White Center.

Rachel Glass spoke in favor SB 1914 to expand film production incentives in the state, which she believed would pass. It would increase from \$3.5 million to \$20 million. She stated that the film industry generates \$10 for our economy for every

\$1 in invested by the program, and we have infrastructure ready to go right in the 34th LD, on Harbor Island.

Our pre-meeting program was given by **Reverend Harriet Walden** from <u>Mothers</u> for Police Accountability. She spoke about how the organization was formed and their current work in police reform.

Guest Editorial: Stop the Privatization of Medicare

The Puget Sound Advocates for Retirement Action (PSARA) is sounding the alarm that traditional Medicare, a program that provides affordable medical care for tens of millions of senior citizens, faces a covert drive to privatize it.

President Trump cleared the way for this dastardly scheme by ordering the Center for Medicare Services (CMS) to use a loophole in Obamacare that permits "tests" of alternative means of delivering Medicare services to improve efficiency and delivery of care. Trump seized on this well-meaning phrase in the Affordable Care Act to ramp up this "test" into a massive, nationwide drive to turn over traditional Medicare to private, for-profit insurance and medical providers. Millions of Medicare recipients were not informed of this plan which the CMS calls "Medicare Direct Contract Entities" shortened by CMS to "DCE." Even today, few people are aware of Medicare DCEs. The Biden Administration has the authority to terminate it since it was initiated by Trump without seeking Congressional authorization.

PSARA and other defenders of Medicare got wind of the scheme. Our own Rep, Pramila Jayapal (D-WA), co-chair of the House Progressive Caucus denounced it. She drafted a letter, co-signed by 53 members of the House, demanding that President Biden terminate the DCE privatization program.

Physicians for a National Health Program is circulating a petition, signed by over 13,000 physicians and health care advocates urging President Biden and Congress to terminate the "DCE" Medicare privatization. To sign the petition please click HERE

The political heat got so hot that CMS announced that the Medicare Direct Contracting Entities (DCE) program will be terminated Dec. 31, 2022. It should have been a time for celebration.

But these same critics looked closely at the program that replaces the DCE, now called Accountable Care Organization REACH (ACO-REACH which translates "Realizing Equity, Access, and Community Health"). Despite the high-sounding phrases, the new program is little better than the original DCE. The old merchandise has been repackaged, cosmetic changes applied to make ACO-REACH seem more attractive. But the essence of the matter is the same: to privatize Medicare so insurance companies and other Wall Street Entities can squeeze profits from it. The cost to us is sharp cuts in medical services, patients facing rejection of services covered under traditional Medicare. and a profit bonanza for Wall Street.

We urge all friends of health and healing, all our allies in the struggle for democracy, equality, and health care to join in this struggle. As workers and taxpayers, we paid for this vital program our entire working lives. HANDS OFF OUR MEDICARE!

Notes From the KCDCC Meeting, March 22, 2022

The meeting opened with legislative session debrief. Legislators Karen Keiser, Tina Orwall, Javier Valdez, and David Hackney offered highlights of the recently concluded session. They noted passage of bills on transportation, dispute resolution for Lyft and Uber drivers, environmental issues, insulin price caps and drug affordability board creation, police reform, behavioral health, housing, and schools. Most mentioned the need for a wider Democratic



margin in both House

There was also discussion of the need to protect the rights of patients from restrictions in light of consolidation of so many health care facilities under the umbrella of Catholic health organizations. Legislators stated that this could best be achieved via ballot measure.

The redistricting debriefing noted that King County has lost the 39th LD and acquired the 12th LD and urged us to

reach out to our new folks. There was discussion of the upcoming caucuses and the need to recruit diverse delegates.

Leah Griffin announced her candidacy for the seat being vacated by retiring Rep. Eileen Cody in the 34th, and Melissa Taylor announced her candidacy in the 46th. Kate Baumgartner updated us on Sen. Murray's recent activities, and Rep. Kim Schrier spoke of the importance of keeping her 8th CD seat in Democratic hands and Arshia Nilchian reported on Rep. Adam Smith's activities on behalf of the 9th CD.

The Endorsements Committee recommended early endorsement for Senator Murray, Representative Schrier, and Secretary of State Steve Hobbs, and all received the 2/3 affirmative vote to secure their endorsements.

Treasurer Melissa Taylor reported a healthy \$82,877 balance in her report. Finance Committee Chair, Tara Gallagher, sought a budget amendment which was approved. She then presented the proposed 2022-2023 budget, with both Basic and Stretch options, and the budget was approved as presented.

Resolution to Stop Privatizing Our Medicare System

Whereas, Medicare has been our national health care system for seniors and the disabled in the United States since 1965; and

Whereas, Medicare beneficiaries are among the most vulnerable populations served by our health care system, and need more, not fewer, benefits and protections; and

Whereas, traditional Medicare, which does not insert a middleman between the Medicare beneficiary and their chosen health care provider, is a public good and should not be privatized; and

Whereas, Wall Street has long sought to profit from public benefit programs, such as Social Security, and has rushed to buy up Accountable Care Organizations managing traditional Medicare services; and

Whereas, the Trump administration opened the door to the complete privatization of Medicare through a Direct Contracting pilot program allowing private equity firms, insurance companies, and corporate health businesses to directly contract to provide Medicare services; and

Whereas, the Biden administration ended the Direct Contracting pilot and rebranded it as the ACO REACH (Accountable Care Organization Realizing Equity, Access, and Community Health) pilot to begin in January of 2023; and

Whereas, public health advocates across the country see little difference between ACO REACH and the Direct Contracting pilot, since both pilot programs allow third party private entities to wedge themselves between patients and their healthcare providers and to draw down the Medicare Trust Fund by making huge profits in several ways, including weakening services for Medicare beneficiaries; and

Whereas, addressing the healthcare resource inequities suffered by BIPOC individuals and communities is best done within the traditional Medicare system and not through a privatized ACO REACH style program;

NOW THEREFORE BE IT RESOLVED, the 34th Legislative District Democratic Organization opposes privatization of our Medicare system; and supports terminating the ACO REACH pilot program and closing the door on third party entities in our Medicare system; and

BE IT FINALLY RESOLVED, a copy of this resolution be sent to the Washington State US Senators and Congressional Delegation, and to President Biden and US Secretary of Health and Human Services Xavier Becerra.

Leah Griffin's SANE Act Signed Into Law by President Biden

Member Leah Griffin saw years of advocacy came to fruition in March as President Biden signed the reauthorization of the Violence Against Women Act. Within this larger bill is the "SANE Act", a product of years of hard work and collaboration with elected officials in the state and nationally.

A victim of sexual assault in 2014, Leah found, as she sought justice, that our medical facilities and law enforcement agencies were largely unprepared to document rape and

pursue offenders. Thus, she turned victimhood into advocacy as she teamed up with Senator Patty Murray and Rep. Pramila Jayapal on the federal level, and Sen. Mankra Dhingra and Tina Orwall in Olympia to find solutions for other sexual assault survivors.

Through her role representing survivors, Griffin was a key contributor to several state laws: To see that rape kits get tested and track them through the legal system; to create standard forensic gathering techniques in hospitals; and to improve the victim interviewing techniques of police.

Now, with the help of Murray and Jayapal, Griffin has seen her work go national. The SANE Act provides \$150 million for such programs as the training of Sexual Assault Nurse Examiners (SANE) and a national map of access points for help for victims after an assault.

Leah gave a presentation to us at our September 2019 meeting. In it she said:

"I took my rage, and I channeled it into reform. What I understand now is that sexual violence intersects with almost every other issue; healthcare, education, economic justice, law enforcement, homelessness. Trauma is at the root of our society's problems, and it is past time that we talk about it. There is so much to do, and I look forward to making those changes together."

Leah is taking her activism in lawmaking and is running for the newly opened 34th LD Representative seat.

Representative Eileen Cody Retires

Eileen Cody has decided to step down from her seat in the legislature after over 27 years of serving us here in the 34th LD, and before that in the 11th, where she was initially appointed to go to Olympia. She will continue to work for us until her successor assumes office next January.

Eileen has also recently retired from 40 years in nursing, working at Group Health Cooperative, now Kaiser Permanente. She is also a founding member of District 1199 NW/SEIU Hospital and Health Care Employees Union. With this basis in medicine, she aptly assumed a leadership role in Washington State's health care system.



In her position as the Chair of the House Health Care and Wellness Committee, she has taken the lead to improve patient safety, mental health parity, public health services and to restore the universal purchase of vaccines. She led the effort to implement the Affordable Care Act at the state level and has been instrumental in making our system a template for the rest of the country.

Many of us have had the pleasure of bidding to get a ticket to her annual cocktail party to help fund the 34th Democrats. She hosted them with her husband Tom Mitchell, and we enjoyed pleasant chat as we watched the late summer sunset. We wish her well, as she is able to enjoy free time, and get some traveling in with Tom. She leaves a legacy of service that will be hard to match.

In the coming weeks we will meet to designate a 34th District member to the Convention Rules, Credentials and Platform Committees. We will also meet to determine which 2 Resolutions we will take to Convention along with up to 32 amendments to the WA State Party Platform. This is where we RAISE OUR VOICE as a District. Sound Transit West Seattle Extension: Raise your Voice!

In 2016, 54% of voters in King, Snohomish and Pierce counties approved ST3, which included the West Seattle Light Rail Extension with projected completion by 2030. Since then, the budget has grown and the timeline has stretched. And we have an alternative to consider which is 1/10th the cost and could be finished in four years.

At our April 13 membership meeting, following a presentation by Sound Transit about their plans, a letter to ST's Board will be voted on. The letter would express preference for an aerial, urban gondola instead of a light rail to connect West Seattle to SODO and the ID.

According to projections in Sound Transit's draft EIS, up to 658 West Seattle homes, 120 of our businesses, and 1,140 jobs could be lost. These figures are just from the Duwamish, Delridge and Junction stretches – they don't include SODO.

Displacement from the aerial gondola with its smaller footprint would be negligible. The gondola can carry more passengers per hour, and the waiting time between cabins is short.

The towers are shorter and slimmer than a light rail would be, the stations are smaller, and the operation is quieter. Urban gondolas already operate in Medellin, Mexico City, and La Paz.

Sound Transit is inviting public comments on its draft Environmental Impact Statement, which shows different routes, costs, and impacts for both the Ballard and the West Seattle extensions, through April 28. Curiously, though, the DEIS doesn't address environmental impacts such as greenhouse gas emissions from the construction/operation or from trees lost or concrete poured, stormwater runoff from more impervious surface and less urban forest, impacts on wildlife, street traffic or noise pollution – all of which would be less impactful or totally benign with a gondola system.

34th LD Democratic PCOs - File For Office May 16th - 20th

During the Primary Election of every even-numbered year, candidates for Precinct Committee Officers (PCOs) file with King County Elections in the precinct where they are registered to vote. A 17-year-old who preregisters and will turn 18 by August 2, 2022, is eligible to run. Elected PCOs will serve two-year terms beginning December 1, 2022 and ending November 30, 2024.

PCOs are partisan positions. Our candidates file as Democrats. Voters in their precinct must affirm that they are Democrats and select only one candidate from their party. (A voter's affirmation is private for PCO elections only and not matched with names or shared.)

If more than one Democrat files in a precinct, names are placed on the ballot for Democratic voters in that precinct to decide who will serve during the August Primary. If only one person files, that person is automatically elected.

Online PCO filing will be available 24 hours a day starting May 16, 2022, at 9 a.m. and ending May 20, 2022, at 4 p.m. Please review the excellent resources available on the King County Election Website:

April Pre-Meeting Program - Choose 180, Transformation Through Choice


