### In Case You Missed Our Last Meeting...

Chair **Carla Rogers** opened the meeting with comments about retiring Rep. Eileen Cody and her legacy.

We had recently completed our LD Caucus. Carla told us that we were only one of five LDs to meet our affirmative action goals, thanks to recruiting by **Rachel Glass.** As a reward, we are allowed 4 additional delegates. We will also be granted 44 platform amendments and 2 resolutions.


Carla expressed happiness to see Ketanji Brown Jackson confirmed to the Supreme Court. Although three republicans voted for her, to accomplish our goals we need a majority in congress. We must step up to help in districts not as strong as the 34th to keep that majority.

**Chris Porter,** wearing his King Conservation District hat, said they are "pulling out all the stops" to see inclusion and diversity in new hiring and organizational focus to bring conservation resources to under-served urban areas, while not overlooking rural areas and farmers.

Our annual fundraiser is back and in-person for 2022. **Gina Topp** is the event organizer, and she revealed the theme of our party this year: **Paint the Night Blue.** Wear blue clothes! There will be blue food and blue drinks! This evening fundraiser will be at **Arthur's Restaurant** on July 14th Those purchasing their tickets the evening of the April meeting were to receive an "Ignite Change" tee-shirt. If you do not feel that you are able to afford a ticket, there are opportunities to volunteer event.

The Candidate Spotlight featured statements from **Kristin Ballinger**, who was appointed by Gov. Inslee in December to fill a position on the King County Superior Court and is seeking a full term. We also heard from Seattle Municipal Judges seeking our endorsement – **Catherine McDowell**, **Adam Eisenberg** and **Willie Gregory**.

2022 will see important elections take place in the fall, and State Chair **Tina Podlodowski** asked that LDs get out in front of our normal endorsement processes, and vote to endorse

Senator Patty Murray, and newly appointed Secretary of State Steve Hobbs. We watched a short video from Senator Murray, then we voted to endorse her for reelection, and then also endorsed Hobbs. **Sound Transit**, at the bequest of Dow Constantine, did a study of the **Skylink Gondola** alternative to the proposed light rail scheduled to serve West Seattle in the coming decade, and has released their report. It was presented by **Matt Shelden**, ST Deputy Executive Director of Planning and Integration, who led the team that worked on the study. **Carrie Avila Mooney**, ST Director of Regional Government and Community Relations, was also on hand to help answer questions.

The study was not favorable to a gondola system as a replacement for light rail, as it would require a transfer downtown and not provide direct connections to the north, nor did it find the capacity to be adequate at peak times. Shelden felt a major sticking point is that the 2016 ST3 Levy approved "light rail" and would require another vote of the people.

It was brought up by members the fact that the study did not look at environmental impacts, and that gondolas could well be less expensive overall vs light rail. Shelden and Mooney both admitted that more research would be required to answer those questions.

The Trump Administration left behind damage to our healthcare system. PSARA and 34th Dems Members **Karen Richter** and **David McLanahan** spoke about one bit of unresolved sabotage to Medicare and Medicaid. They explained a hidden means of privatizing these important public systems. A pilot program called Direct Contact Contracting was launched in 2019. It allows private, third-party middlemen (Direct Contracting Entities, or DCEs) to manage the delivery of health care for a fee. No knowledge or right-of-consent is given to beneficiaries. Medicare pays, and the DCEs pocket any leftover money, giving them ample incentive to restrict care. There is no congressional oversight. The DCE program is to be discontinued in December...but the Biden administration will launch a replacement in 2023 with a goal of addressing equity: Accountable Care Organization Realizing Equity, Access, and Community Health (ACO REACH). Unfortunately, public health officials find the same issues with ACO REACH as with the DCE program and will affect the long-term viability of the Medicare Trust Fund.

PSARA is asking organizations to pass resolutions and sign onto letters to our Washington US Senators and Congressional delegation and to Secretary of Health and Human Services Xavier Becerra requesting that these programs be terminated. To do our part, <a href="weepassed">weepassed a resolution against this scheme</a>.

Topping off the packed agenda was a presentation of Ranked Choice Voting from Fair Vote Washington presented by Sam Perera and Kit Muehlman. It was an interesting follow-up to the presentation on the less well-known Approval Voting concept we had earlier in the year. Fair Vote has two initiatives coming up, in Clark County and San Juan County to approve ranked choice elections.

### Snake River to Salish Sea Spirit of the Waters Totem Pole Journey to Promote the Removal of Snake River Dams

Se'Si'Le, an intertribal non-profit, is supporting the trek of a totem pole through the Northwest during the month of May. Se'Si'Le invites people to stand with Lummi tribal members, the House of Tears Carvers and Tribal communities across the Pacific Northwest in support of this journey and the Indigenous-led movement to remove the Snake River dams. This important journey comes at a critical time for the Snake River, endangered salmon and orcas, and the region's Tribal communities.



The totem pole will make 10 stops in Washington, Oregon and Idaho starting on May 3 and with a penultimate stop in Seattle on May 19 (the last stop is Tacoma on May 20). You can see it on the campus of the U of WA, in the Longhouse (aka Intellectual House) NE of the Quad, from 6-8 p.m. on the 19th. Click HERE for a map.



The Save Our wild Salmon Coalition and many other non-tribal groups are working to support these tribally-led events by boosting turnout. Here's a link to a web page with more details and the entire schedule of the journey.

The strong and insistent voices of Northwest Tribes have been essential in creating the political and legal openings that give us hope of finally solving these intractable issues in a way that recovers endangered salmonids and orcas, while bringing everyone forward together. Support for those indigenous voices by non-tribal Northwesterners has a powerful multiplier effect.

The 34th District Democrats <u>passed a resolution</u> at our November 10, 2021 membership meeting in support the Northwest Tribes in their efforts in salmon recovery and of the breaching the four lower Snake River dams.

### Justice Barbara Madsen Seeks Our Endorsement



Justice Barbara Madsen is running for re-election, and she's asking for our support. Following is an account of her accomplishments.

In 1998, she was appointed chair of the Washington State Gender and Justice Commission. The Commission, partnering with other community groups, succeeded in passing legislation banning the shackling of women prisoners during labor. Under her direction, the Commission has produced the Domestic Violence Manual for Judges, the Sexual Orientation Benchguide, the Sexual Offense Benchguide, and the Immigration Resource Guide for Judges, in partnership with the Minority and Justice Commission, as well as developing judicial education on a wide variety of gender issues and

model policies designed to enhance the safety of victims of domestic violence. Additional accomplishments:

- In 2001, Justice Madsen facilitated Washington's first Glass Ceiling Study.
- In 2004, Justice Madsen co-chaired the Crystal Brame Committee which secured legislation requiring all police agencies to adopt investigation protocol for police perpetrated domestic violence and sexual assault.
- In 2005, she helped establish the Initiative for Diversity, a program encouraging legal employers to commit to and
  implement organizational plans to increase diversity. As chief justice, Madsen was instrumental in the development of a
  limited legal license technician program, the first in the nation, to address the critical justice gap for low- and moderateincome people.
- In 2013, Justice Madsen led the Supreme Court efforts to develop the Tribal State Court Consortium, encouraging and building partnerships among tribal and state judicial officers.
- In 2019, Justice Madsen was appointed co-chair of the Washington State Supreme Court Commission on Children in Foster Care, in which stakeholders work to improve court processes, laws, regulations and policies so children can move safely and quickly into stable homes, through reunification with parents or through adoption.
- In 2020, she was appointed chair of the Judicial Information System Committee. The committee oversees information technology for Washington courts, automating and supporting the daily operations of the courts and maintaining a statewide network connecting the courts and partner criminal justice agencies to the JIS database.

Madsen was elected as the third woman to serve on the Washington Supreme Court in 1992. Justice Madsen was unanimously elected by her colleagues to serve two terms as the 55th Chief Justice of the WA State Supreme Court, from 2010-2017.

# A Resolution Stating the 34th Democratic Legislative District's Preferred Alternative for a West Seattle Extension and Calling for a New Independent Study

**Whereas,** Sound Transit (ST) issued a Draft Environmental Impact Statement (DEIS) on the West Seattle Ballard Extension alternatives and is currently receiving public comment on the DEIS; and

**Whereas,** ST3 includes light rail construction in South Downtown (SODO) and West Seattle, areas located within the 34th Legislative District: and

**Whereas,** the members of the 34th LD Democratic Organization live and work in these areas and have a substantial interest in the location, mode, construction, operation and costs of future transportation in this community; and

Whereas, having reviewed the DEIS they find the following issues and concerns:

- The document does not adequately address the years of traffic congestion and obstruction, noise and greenhouse gasses emitted during construction of any light rail alternative.
- Nor does it observe the disruption and destruction of mature urban tree canopy, which cannot be replaced.
   Trees help control stormwater runoff, improve air quality, provide wildlife habitat, and sequester carbon emissions.
- The DEIS does address the loss of 658 housing units, 120 businesses and 1,140 jobs in the Delridge, Duwamish and Junction neighborhoods of West Seattle alone not including impacts on the International District. These losses will seriously harm our community and cannot be easily or cheaply mitigated.
- The increase in cost of the West Seattle extension and delay in completion until at least 2032 will result in added environmental impacts related to climate altering emissions, air quality and other effects. We are concerned that these impacts make any light rail alternative untenable and speak to the need for a cheaper, more rapidly deployable option.

**Whereas,** a new alternative, an urban aerial gondola, has been identified that is not addressed in the DEIS, but shows promise in its cost, faster implementation schedule and reduced environmental impacts; and

**Whereas,** such major urban systems have been successfully implemented in cities such as Ankara, Turkey; Mexico City; and La Paz, Bolivia, where they can carry as many as 4,500 passengers per hour, as opposed to the projected 3,200 per hour for the preferred light rail alternative. The cumulative impacts of that differential would be substantial; and

**Whereas,** it is projected the gondola system could be operational by 2026, greenhouse gas emissions could be reduced/avoided more than six years sooner than the preferred alternative;

Whereas, it is also projected that the gondola system would cost 1/10 that of any light rail alternative;

**Now therefore be it resolved,** the 34th District Democratic Organization prefers an aerial urban gondola system to serve the transportation needs of our community, over any proposed light rail alternative, and urges Sound Transit to contract with an independent consultant for a new study of the gondola system compared with the light rail for West Seattle, including projected cost, completion date and environmental impacts.

**Be it further resolved,** this resolution be sent to the Sound Transit Board as our comments to the DEIS and to the Seattle Mayor and City Council for their consideration.

### **Resolution in Support of the Keep Our Care Act**

Whereas, mergers and acquisitions between health care entities, i.e., hospitals, hospital systems, and provider organizations are prolific across the country and in Washington State, negatively impact cost, quality, wait times, and access to legal health care services; and in Washington State these health care entity consolidations receive minimal oversight, allowing large health care systems to dictate patients' access to care, including reproductive, end-of-life, and gender-affirming care while in other states such as Oregon, Massachusetts, and California they have regulations which require oversight of mergers & acquisitions of health care entities[1]; and

**Whereas,** mergers and acquisitions have been proven to drive up costs for patients in Washington State and leaving communities without access to public health care as noted in 2017 when Washington's Attorney General sued CHI Franciscan in a federal anti-trust lawsuit regarding consolidations that resulted in raised prices, increased wait times, and reduced services and locations[2]; and

**Whereas,** A recent study by The New England Journal of Medicine found that hospital acquisitions are associated with moderately worse patient experiences. Washington hospital data indicates that our health system ranks poorly in quality measures, with patient satisfaction scores that are lower than independent hospitals; and

**Whereas,** these consolidations restrict staff, in faith-based consolidated care centers, from providing legal, critical services, and yet they continue to take taxpayer dollars. Due to these consolidations and mergers, Washington State's hospitals were in 2021 49% religious based[3]; and

**Whereas,** mergers and acquisitions exacerbate systemic inequities. Private health systems' efforts to increase revenues leads to worsening health care access and outcomes for Medicaid patients, disproportionately People of Color. About 30% of the population in Washington State identifies as non-white, but over 40% of WA State Apple Health patients are People of Color.

**Therefore, be it resolved**, the 34th Legislative District Democrats urge our Washington State legislators to pass and the governor to sign the Keep Our Care Act, to join other states, such as Oregon, Massachusetts, and California:

- To prohibit health care entity consolidations that diminish access to affordable quality care;
- To require Attorney General oversight, compliance, and enforcement power to ensure health care consolidations do not negatively impact access to health care services
- To institute a health equity assessment so that consolidations/mergers address the needs of marginalized communities; and
- To institute public hearings and comment opportunities prior to proposed consolidations; and

**Therefore, be it finally resolved**, that a copy of this resolution will be sent to the WA State Legislators and the Governor.
