See You In-Person September 14th!



Mark your calendar. This should be a good one.



When vast numbers of people around the world demand the abolition of all nuclear weapons, they will be eliminated. Help Seattle plant the seed of a growing movement throughout the world demanding the universal abolition of nuclear weapons.

Resolution Declaring and Responding to a Climate Emergency

Whereas in their February report, Climate Change 2022: Impacts, Adaptation and Vulnerability, the International Panel on Climate Change (IPCC) concludes that to hold warming to "well below" 2°C, while "working to limit it to 1.5°C above preindustrial levels," global carbon dioxide emissions would have to peak by 2025 and emissions would have to be cut by between 30% and more than 40% by 2030; and

Whereas the IPCC found that our current emissions course, if continued unabated, will lead to warming of about 3.2°C (5.8°F) above preindustrial levels; and

Whereas existing and soon-to-mature technologies offer multiple opportunities for clean energy, energy efficiency, and decarbonization of hard-to-clean-up sectors of the economy; and

Whereas the IPCC concludes that the barriers to achieving ambitious emissions cuts are more social and political than technological, with scientists citing "opposition from status quo interests" as a key blocker of progress; and

Whereas governors across the country have declared emergencies for floods, drought and other natural disasters linked to changing weather patterns resulting in large part from climate change;

Now therefore be it resolved the 34th District Democrats urge Governor Jay Inslee to formally declare a state of climate emergency pursuant to The Stafford Act (§401) and ask the Biden administration for all the customary related recognition and financial relief that would be provided in any other declared emergency.

Be it further resolved Governor Inslee and the Washington State Legislature commit to a statewide mobilization effort to reverse global warming and the ecological crisis, which, with appropriate financial and regulatory assistance from State and Federal authorities, will end statewide greenhouse gas emissions as quickly as possible and no later than 2030 and immediately initiate an effort to safely draw down carbon from the atmosphere, ensuring a just and equitable transition for residents and accelerating adaptation and resilience strategies in preparation for intensifying local climate impacts.

Public schools belong to the entire community, and students who graduate become adults who in turn support the community. That's why it's essential that we, as a community, support our Highline schools. You will have that opportunity on November 8 by voting to approve Prop. 1: the Highline Public Schools Bond.

Highine's Capital Facilities Advisory Committee (CFAC), a group of community volunteers, developed this bond plan to improve our school facilities so every student has access to a safe, modern learning space. the Highline School Board voted unanimously to place this bond on the November 2022 ballot.

This bond will:

- Rebuild Evergreen High School (68 years old)
- Rebuild Tyee High School (60 years old)
- Rebuild Pacific Middle School (63 years old)
- Replace Transportation building L (over 70 years old)
- Replace the dirt field and track at Sylvester Middle School with synthetic turf
- Make critical repairs and improvements at schools across the district

The bond amount is \$518 million, but there will be NO INCREASE IN THE TAX RATE

for property owners because of expiring school funding measures. Our aging schools were not built to current earthquake and fire standards, have multiple entrances that would be difficult to secure against an intruder, and are not able to support today's learning technology.

- Voter support of our long-term capital facilities plan is critical so our schools reflect the values and priorities of our community. We need schools that keep our kids safe and ensure graduates are ready to support our communities in the future.

August Meeting Recap

A Pre-Meeting Program on police reform was presented by the Law, Justice and Civil Rights Caucus. The talk was introduced and moderated by caucus lead **Bill Schrier**, delivered by 34th Democrats Member **Rob Saka**.

Rob is a cyber security attorney, a justice reform advocate, an air force veteran...and is currently on the Seattle police chief search committee. He was also a member of the commission to amend the County Charter in 2021. His talk focused on developments in local justice reform efforts. He calls the

death of George Floyd, which reminded him of an unfortunate personal encounter he himself had with police, an event that still affects his on law enforcement. Another incident that impacted him was the Boston Marathon Bombing, an event he was participating

in, and the brave response by the police that day. He used those incidents to illustrate the good and the bad of law enforcement. Transparency, trust, and accountability are the keys to effective reform, and Rob explained how those principles are manifested in the King County Charter Amendments voters approved last year.

Chair **Carla Rogers** kicked off the meeting from a hotel room in Boston, where she was attending a conference. Making the situation even more interesting, the hotel was evacuated due to a fire alarm, then further complications due connection issues also arose. Vice Chair Rachel Glass was at the ready to pick up the slack, and the meeting was conducted with minimal downtime.

Carla spoke of the recent primary races around the country, and here in Washington. The Trump effect was felt in the Republican primary contests, including the ouster of one of the Republican impeachment supporters Jamie Herrera Beutler in WA-03, leaving one of his extremist disciples going into the General Election. Marie Gluesenkamp Perez will be our standard bearer in that district.

Joe Fitzgibbon countered with encouraging news when he spoke. Our Democratic candidates did well on the state level and bucked a "Red Tide". Voters rejected the GOP message, rewarding Democrats for getting things done both here and in DC. There is real fear of what the Republicans would do once they took back power, especially considering the recent Supreme Court ruling that striped away federal abortion protection.

The September meeting on the 14th will be in person at our old home at the Hall at Fauntleroy! Walk lists and canvassing materials will be distributed during the meeting. We go back to Zoom for October, then we meet again in person for the November 9th meeting, which is the day following the General Election. This will be the last meeting of the year, and at that time there will be a Q&A with the Legislators, the 2022 awards will be presented...and a special tribute to Eileen Cody is planned. A service project yet to be determined will take place in lieu of a December holiday party.

The Speak Up Forum question for the month asked whether there is interest in hitting the streets in our community to do sign-waving for raising public awareness of hot issues such as reproductive rights and gun control.

We endorsed King County Proposition 1 – The Conservation Futures Program Levy. This measure is on the November ballot and will restore the Conservation Futures Fund to its original level. It was enacted 40 years ago as a measure authorized by state law and enacted at the county imposing a property tax for acquiring and protecting forest, farmland, and other open space throughout the county. About 100,000 acres have been protected to date. But over the years, the tax rate has been decreased. Prop. 1 would re-fund the program at its original rate of 6.25 cents per \$1,000 of a property's assessed value in 2023, up from the current rate of 2.75 cents.

King County Executive **Dow Constantine**, who described Prop. 1 and spoke for the levy, stated that Prop. 1 "...will

allow the county to do in a single generation what, at our current rate, would otherwise take us a hundred years to protect". 66,000 additional acres that are identified as the highest priority and highest value properties in the county to protect for all time...easing stress to the environment while helping to ensure that citizens have easy access to natural spaces including parks and wooded areas.

The body also passed a resolution submitted by **Ann Martin** "Calling for Passage of the Local Journalism Sustainability Act". This resolution is in support of an act introduced by Senator Maria Cantwell to stabilize and reverse losses of local newspapers and the investigative reporting they do. The State Party passed this resolution at the state convention in June...read it **HERE**.

Two new PCOs were appointed: **Dorothy Gesick** in SEA 34-1480, and **Soleil Lewis**, who assumes leadership of Bernice Precinct in White Center. **Nick Bonazza** swore them in, then he laid out the GOTV plan. The kickoff for the 34th will be at the September meeting. We will also help re-elect Kim Schrier in WA-08, and 2 canvassing trips are scheduled for the 10th and 25th of September.

Report from the KCDCC August 30 Meeting

Endorsements were the bulk of the agenda for this meeting and since the list of items to go over was rather short our chair, Shasti Conrad hoped for a quick meeting...It didn't work out that way.

There was a pre-meeting event on how to vote, KCDCC uses a somewhat unusual method of voting via messages to a set group of tabulators that allows a close control of who votes. I did not attend this, I've gotten to know the drill.

Opening items

We started with a call to order, acknowledgment of tribal lands, and an approval (by acclimation) of the June minutes. That was followed by the Chair's report. Shasti congratulated everyone on what was by and large a great primary. She felt that it helped that the GOP put forth candidates that were too extreme for Washington voters, even conservative ones. She highlighted many of the Democratic successes at the polls. She says it was the best off-year primary in two decades. A couple of people are leaving KCDCC: Dean Fournier, leaving the area for retirement and Benton Coblentz, who's involved with endorsements and also Chair of the 11th is moving to DC to take a job with the Atlantic Council.

Next Hanna Floss spoke about opportunities to be an election observer. She also mentioned that King County Elections won an award for its observer program. Alexander Erickson of Coordinated Campaigns also spoke.

Treasurer's report

Next there was a budget update from Treasurer Melissa Taylor. Although revenues did not meet expected levels for the period KC Dems is financially sound with adequate reserves in the bank.



Endorsements

The Endorsement Committee gave a report explaining their process for endorsements now. All endorsed Federal and State-wide candidates advanced through the primary so there is nothing to do on this front. 34 of 36 Legislative candidates advanced through the primary also. So, the only thing KCDCC would potentially have is if an LD endorsed a new candidate, then KCDCC could potentially also endorse that candidate. No LD had done that at the time of the meeting.

Then a motion was made to endorse King County Even Year Elections. Since no one indicated a desire to speak against the resolution it was passed by acclimation.

Next a motion was made to endorse Seattle Rank Choice voting. Some background: Signatures were gathered to pass Approval Voting. However, when presented with an initiative that has the required number of signatures the city council has several options on what it can do. It can just pass it, or it can put it to the vote, or it can put it to the vote with an alternative option it picks. This last choice is the path the council decided to take. We had a guest speaker who was there to both speak for a potential motion and to also just provide info on how the two types of voting work. In addition to a discussion on the merits of the voting methods there was an extended discussion of how this will appear on the ballot. The gist of it is that there will be a yes/no vote on changing voting method, then will a second question where voters are asked to pick between Approval and Ranked Choice. When the discussion ended the KCDCC voted to endorse Rank Choice Voting. This had to get over a 2/3's vote because the endorsement committee did not take a position on the issue.

Resolutions

There were four resolutions to be considered by the body at this meeting and were passed as a slate by proclamation:

- In favor of Reinstating the Expanded Child Tax Credit
- To Save Our Democracy
- Calling for a Temporary Waiver of TRIPS Restrictions on COVID-19 Vaccines, Tests and Treatments
- In Support of "Conserve Our Futures": Vote YES on Prop. 1

Planning for general Election

Shasti discussed KC Democrats priorities for the fall general election. The primary activities will be supporting Representative Schrier and Lisa Manion.

We also received Information on the September Fundraiser and KC Democrats Summer Picnic in September 11th.
