

## State Committee Report for Meeting of January 28, 2023

Tina Podlodowski gave her outgoing message to the newly assembled state committee. She thanked many people for their work and service to the state committee. The staff currently in place will remain with the new Chair.

### DNC reports:

- Senator Javier Valdez was appointed to a standing committee. Three of our DNC members are on standing committees. This is important, because there are over 490 members of the DNC body, but only 90 members are on standing committees. It is highly unusual that three of those members are from the state committee. This is historic.
- David McDonald spoke about the historic appointment of Sen. Javier Valdez to a standing committee and gave the historic content mentioned above. He also reported that rank-choice voting was referred to a sub-committee for review but does not believe it will gain traction during this election cycle. Delegate selection plans are due May 3rd with an initial review in June or July. New Hampshire would like to remain the first state to hold a primary or caucus.
- David Green reported that he is in contact with DNC every other week to keep them updated about the ins and outs in the state of Washington. He also reported that there are about 10 states that have a paid full-time state party Chair and the average serving time of a state party Chair is 1.75 years. During the Presidential election cycle, this is very problematic. There is talk about changing terms of service to 4 years instead of 2 years.
- Sharon Mass spoke about the 5-state alliance.

## In Case You Missed It...February Meeting Recap

The first pre-meeting program of the year celebrated Black History Month, the presentation was given by **Malakhi Kaine**, the Executive Director of Seattle-based [Africatown International](#).



*Malakhi Kaine is from Africatown International, an organization based here in the 34th Legislative District.*

Africatown International works primarily with African American families who are at the edge of security to provide resources to help keep them from falling through economic cracks. Its namesake is derived from a site near Mobile, Alabama, which was the final resting place of the last slave ship coming from Africa in 1860. After the Civil War the area was settled by former slaves, who kept their African culture alive into the 1950s. This period served as a starting point for Kaine's discussion.

He relayed his childhood experiences with Martin Luther King Day while growing up in AZ, where there was antipathy to the holiday. Similarly Black History Month, while it is a celebration, can be laced with trauma as it recalls the struggles of Black people in their fight for equality and social justice in the United States.

He laid out a timeline that hit on several key decades in history beginning in 1900, coming out of Reconstruction, through events in 2020. This program is available to view on YouTube:

**Graham Murphy** opened his first meeting as Chair. After taking care of the initial business, Graham asked members to take part in a poll that will help decide the frequency of in-person meetings for the rest of the year.

VIPs present included King Co. Executive **Dow Constantine**. He was asked to share an update on the Behavioral Health Crisis Centers Levy being put forth in an April 25th Special Election. It will make up for the current lack of capacity to help those who are in mental health or

addiction crisis in King County. This effort is supported by the labor and business communities, and will create five Crisis Centers across the county, including one that will be devoted to youth. He spoke to the broader issue of behavioral problems that cause property crimes and overrun our courts and jails, across the county, state, and around the country. This levy would cost about \$10 monthly for an owner of a median-price home of \$800,000.

Later in the meeting, **Gina Topp** rose to move the consideration of endorsing the levy. Since the endorsement was not on the agenda, we first had to vote to allow for an endorsement vote which we did via a voice vote. After this hurdle was overcome, we endorsed the levy by 100% using a Zoom poll ballot.

A question was raised by **Dorothy Gesick** as to why we're having another special election in April, after just having one in February. Dow explained that a Veterans, Seniors, and Human Services Levy would be on the August Primary ballot for renewal, and that Seattle will have a housing levy in November. Therefore, it could be as long as two years before it would be feasible to take the Behavioral Health issue to the voters.

King Conservation District Board member **Chris Porter** is running for reelection and spoke about that race. Reminder cards for this special election process had gone out, and as a result the number of voters had already exceeded the total returns from the last KCD election. Chris testified at a hearing in Olympia for House Bill 1567 that would investigate the cost of moving these elections across the state into a regular county election format. He also spoke about the native plant bareroot sale that was to end February 17, and to a KCD listening session to help with strategic planning for the organization.

Seattle City Councilmember at large **Teresa Mosqueda** rose to thank Executive Constantine for his work on the behavioral health levy, for which she has been partnering with the county. The city will be sponsoring a housing levy later this year that will put investments into building workforce housing options, and Seattleites are invited to weigh in with comments in April, May, and June. Recently retired Rep. **Eileen Cody** popped in to remind us she's no longer a representative, and she's happy to be "just one of the gang".

Judge **Joe Campagna** was in the Candidate Spotlight. He was appointed by Governor Inslee last year and is running to retain position 39 as a trial judge on the King County

Superior Court. While as a lawyer, he said that he took pride in representing a number of individuals to seek clemency from serving decades of federal prison time for non-violent drug charges. He has also represented mothers and children seeking asylum after fleeing gangs and violence in their home countries.

Positions also needed are Equity & Social Justice Committee, and Elections & Caucuses Committee Chair. A Young Democrats Liaison is also sought. 

# Resolution in Support of a Washington Tax on Extreme Wealth (SB 5486 and HB 1473)

**WHEREAS** the 34th District Democrats platform supports wealth taxes and the Washington State Democrats have called for “fair and just tax system for all; by creating a progressive wealth tax;” and

**WHEREAS** Washington State has the most regressive tax system in the country, with the bottom 20% of Washington’s lowest-income residents paying nearly 18% of their income for state and local taxes, while those in the highest 20% income bracket pay less than 7% of their income for state and local taxes; and



**WHEREAS** Washington State is facing a crisis in funding for public schools, housing and homelessness, developmental disability services, climate change resilience, public transit and transportation, physical and mental health care, and more; and

**WHEREAS** Senate Bill 5486 and House Bill 1473, which are titled “Investing in Washington families and creating a more fair tax system by enacting a narrowly tailored property tax on extreme wealth derived from the ownership of stocks, bonds, and other financial intangible property,” propose a 1% tax on financial property in excess of \$250 million, with revenue collected funding public education, housing, disabilities, and taxpayer justice; and

**WHEREAS** SB 5486 and HB 1473 would generate more than \$6 BILLION per biennium for Washington (according to SB 5486’s fiscal note), and affect about 700 Washingtonians fortunate enough to have more than \$250 million in wealth; and

**WHEREAS** Senator Nguyen and Representative Alvarado are co-sponsors of SB 5486 and HB 1473, respectively,

**NOW THEREFORE BE IT RESOLVED** the 34th LD Democrats support the creation of a wealth tax as defined in SB 5486 and HB 1473 to fund needed services for Washingtonians, such as public education, housing, disability programs, climate change resilience, public transit and transportation, and health care; and

**BE IT FURTHER RESOLVED** the 34th LD Democrats call on all Democrats in the Washington State Legislature to wholeheartedly support passing these bills.

Submitted to the 34th LD Democrats February 2023 by Bunny Hatcher. This resolution was approved by the Executive Board to be presented members at the March 8, 2023 meeting with a recommendation to adopt. Members may speak in favor or against per our [Bylaws](#).
