Chair's Message

Happy tax season! I get a strange joy out of the tedium of finding and organizing all the paperwork necessary to complete convoluted tax forms. I probably would have enjoyed a job as an accountant if not for the math of it all. What I don't enjoy is knowing I live in a state with the most regressive tax regime in the country. In Washington State, [the lowest-earning residents "pay almost 18% of their annual incomes in state and local taxes, while the wealthiest chip in 3%."](#) Our approach to taxes also disproportionately impacts communities of color.

Thankfully, we have some reason to celebrate this tax season! Our [State Supreme Court recently upheld a law Democrats passed](#) to impose a 7% tax on capital gains that exceed a \$250,000 threshold. This sound decision will not only get more resources to support early learning and childcare for those communities most in need, but it also gets us closer to ensuring our wealthiest Washingtonians pay their fair share in taxes. Additionally, a new [Washington Working Families Tax Credit](#) gets regressive tax money back to those who need it.

Those of us who have access to significant personal resources have an obligation to give back through taxes and advocate for a more equitable system that creates a strong middle class and helps lift people out of poverty. There are big things only the government can do and that we all benefit from, like building roads and bridges, educating our young people and future workforce, and protecting our environment. It is immoral to put the burden on those with the least means to pay for the big things we all enjoy. And it is unconscionable to uphold a tax system that perpetuates and worsens income inequality.

I am proud that our membership recently adopted a resolution to support a [tax on extreme wealth](#). This also supports our march toward a more equitable tax system that ensures resources get to those in our community most in need.

There's more to be done, and this year there's progress to celebrate.



We participated in a stakeholder meeting discussing the possible passage of a minimum wage ordinance for unincorporated King County urban areas - Skyway, White Center and Vashon. There is an active proposal to pass a minimum wage ordinance in Burien, which the committee will consider for the April Board meeting. We will wait to meet to discuss the resolution until our new committee member returns from India. Consideration before June is likely to be timely.

In Case You Missed It...March Meeting Recap

Pre-Meeting Program - Southwest Youth and Family Services

Steve Daschle, director of [SWYFS](#), was guest speaker at the March pre-meeting program. He described the work his organization does in our district. The multi-service

agency has been in operation since 1979, Daschle took the lead in 1988.

With a \$7 million budget and 92 employees, SWYFS serves about 2,600

families annually, helping with counseling in several contexts such as in area schools, educational programs to keep children engaged in school, and family resources through home visits and facilities onsite at large apartment complexes with its [New Futures](#) program that is designed to help support working families providing afterschool programs and skills training...serving as a “second living room”.

SWYFS also has a family resource center focused on immigrants and refugees providing help navigating unfamiliar systems in our society. Home visits are provided to strengthen communication bonds between parent and child and to serve as early intervention to help the child focus on school.

The organization is near completion of a \$45 million capital campaign working with area group Community Roots Housing to build several housing projects, with human services as a key component of each site. The biggest of these will be on the site of the current White Center Food Bank and will have 76 affordable housing units. This site will also be home to SWYFS, the White Center Community Development Association, feature numerous facilities for youth, and a healthcare center.

Daschle lamented the fact that those who work in the human services sector are not well-paid, earning 37% less than comparable positions in other industries. Sometimes they themselves are beneficiaries of the very benefits they help others to obtain. Filling positions and maintaining employees is a major issue, one that can affect the quality and quantity of the services provided.

[A University of Washington study](#) attempts to address these funding issues, and it is being published around the area to highlight this funding deficit. A funding mechanism built on the national Consumer Price Index would help keep funding levels constant from year to year.

The SWYFS is part [Seattle Human Services Coalition](#), a group designed for service agencies to speak with one voice when dealing with government.

The business meeting began about 7:30, and we learned as Chair **Graham Murphy** gave his announcements that our long-time male State Party Committeeperson, **Chris Porter**, would be stepping down from that position at the end of March. Graham assured us that he and Chris are exploring other roles for Chris in the organization.

VIPs in the House! Burien Mayor **Sofia Aragon** rose to mention that the City of Burien is celebrating its 30th anniversary of its incorporation...Seattle City Councilmember **Teresa Mosqueda** informed us that there will be a three-month comment period starting in April for citizens to weigh in on a Seattle Housing Levy, scheduled for the November election...County Councilmember **Joe McDermott** spoke about legislation he is working on to help alleviate some of the issues facing residents near the King County Airport, such as noise, adverse health effects, and traffic problems. He is not seeking reelection this year...King Conservation District Board Member **Chris Porter** thanked us for our support in his reelection bid. Although he was unsuccessful, he will still advocate for conservation efforts, especially for pollinators...Former Burien Deputy Mayor **Krystal Marx** and **Drew Estep**, Party Affairs Director of the Washington State Democrats, were also present and acknowledged by the Chair.

Candidate Spotlight brought **Teresa Mosqueda** back to the floor, who will be running for King County Councilperson Position 8, the seat currently held by outgoing Joe McDermott. **Krystal Marx** is seeking the Burien City Council Position 6, which is being vacated by Sofia Aragon. King County Judge **Coreen Wilson** is running to retain her seat; Governor Inslee appointed her to the office in 2022.

We also received an update on the [Yes on Prop. 1 – the Crisis Care Centers Levy](#) coming on April 25th. Campaign spokesperson **Ryan Haskins** said there would be phone and text banking opportunities, but there wasn't a plan to

send direct mailings to voters. (However it was subsequently announced that there would be such direct outreach.)

Resolution: In Support of a Tax on Extreme Wealth

A resolution in support of legislation being sponsored by **Sen. Joe Nguyen** and **Rep. Emily Alvarado** for a state tax on extreme wealth was brought forth by Bunny Hatcher and explained by Ann Martin. Chris Porter moved, and Julie Whitaker seconded a motion to adopt. Bunny spoke in favor of the resolution. It was passed by a Zoom poll vote of 30 to 2. [Read the Resolution HERE.](#)

Work is underway by an ad hoc committee to plan candidate forums/debates. Seattle Council District 1 and County District 8 will be prioritized and the 34th will work with the 33rd for Burien City Council forums and will consider endorsing in overlapping Seattle Districts if approached. Chair Murphy urged members to [verify their membership](#) status to be assured that they are eligible to vote (See Page 4).

We are seeking to hold quarterly in-person meetings, or a minimum of two per year, starting the second quarter of this year on this topic. Chair Murphy spoke about results of a membership survey on this subject. While virtual meetings are more accessible, with less transportation issues, in-person meetings are more conducive to social interaction between members and access to elected officials. It was also noted that shorter meetings are preferred.

PCO Appointment

PCO Committee Chair **Dorothy Gesick** inducted a new PCO. **Drew Estep**, a State Party staffer who was recognized earlier in the meeting. He will be assuming duties in Sylvan Precinct in White Center. In addition to his role at the state party, many of us will remember Drew as our district's Coordinated Campaign leader in 2016.

Treasurer's Report

Treasurer **Julie Whitaker** gave the financial report. **Chris Porter** rose to remark on how well off the 34th is in comparison to many other LDs in the state. All funds will be out of Umpqua Bank by the end of the fiscal year and will be transferred into the BECU. All further financial activities will be done through that credit union. Membership was at 137, including 66 PCOs, as of March 6, 2023.

Good of the Order

Steve Butts announced that there would be an evening Outreach meeting on Zoom Monday, March 13...**Dorothy Gesick** noted that there is growing public concern over public safety and that we should not ignore this sentiment...**Chris Porter** reflected that while he enjoyed the pre-meeting program, he felt we missed an opportunity to have a special program to celebrate Women's Day, which fell on the date of our March meeting...**Ann Martin** came forward to say that the program for the March meeting of the West Seattle Democratic Women would be on indigenous women.

Meeting Notes From King County Democratic Central Committee

Notes From the March 28th Meeting...

In her report Chair Carrie Barnes noted the need for more volunteers for various committees. She noted that the Endorsement Committee work leads to 94% of KCDCC-endorsed primary candidates moving forward to the general election. She concluded with a reminder of the importance of organizing and volunteering to support the Behavioral Health Levy which will be on the April 25th ballot.

Code of Conduct Committee members Catherine Creason, Jen Carter, Crystal Finsher and E.J. Juarez were unanimously confirmed.

The Candidate Questionnaires prepared by the Endorsement Committee were adopted, with the striking of one question on the Judicial Questionnaire. A proposed Light Rail question addition was deferred to possible candidate interview questions.

The 2023 Budget was adopted, with the inclusion of a paid staff position. Melissa Taylor offered the Treasurer's Report. Kristina reported on the activities of the Candidate Recruitment and Support Committee and noted plans to reach out to strong democrats via text messaging.

Paul Chapman sought support for the Wealth Tax Resolution already passed by most King County LDs, including the 34th, and it passed unanimously by acclamation.

...and From the Meeting on February 28th

Chair Barnes reported on the work being done by the DEI, Outreach & Candidate Recruitment, and Endorsement Committees, and reiterated the need for Democrats to have candidates running for every one of the 311 seats up for election this year. She recapped the February 14th Special Election results as well, noting the passage of I-135 and failure of the Enumclaw School District Levy.

Vice-Chair Jeremy Barksdale and County Executive Dow Constantine provided information on the upcoming April 25th Special Election on the proposed Crisis Care Centers Levy. This would create 5 walk-in clinics offering immediate mental health care, and one of these would be strictly dedicated to youth. Constantine asked for a KCDCC endorsement of this levy, and it was endorsed unanimously by voting members.

Guest speakers Lisa Daugaard (Public Defenders Association), Brandi Flood (Law Enforcement Assisted Diversion/LEAD), and Dominique Davis (Third Avenue Project/TAP), provided a powerful presentation on what has been successful in lieu of police response when helping highly marginalized people with behavioral health issues, especially those who are unsheltered and dealing with trauma history and substance use disorder.



Treasurer Melissa Taylor reviewed the budget structure and Standing Rules and presented the Treasurer's report. Endorsement Committee Chair, Martin Chaney, urged members to review the final draft of the Candidate Questionnaires which will need final approval at the March 28th meeting, as candidate interviews are scheduled to begin by April 15. PCO Chair, Alexander Erickson, reported on PCO efforts in the successful passage of I-135 (Social Housing) in the recent special election, cited available training, and called for more people to become PCOs.

Here is Your Chance Review and Comment on Washington Democrats 2024 Delegate Selection and Affirmative Action Plan - By April 29th.

The [Proposed 2024 Delegate Selection and Affirmative Action Plan](#) is now live and [accepting public comment](#). Both items can be accessed on www.wa-democrats.org via the [Party Documents Page](#). The comment period runs until April 29.

The **Delegate Selection and Affirmative Action Plan** (DSAAP) outlines how our State Convention, held every even year, functions, and how the delegates are elected. In addition, in presidential years, it outlines the process by which we elect individuals to represent Washington State at the Democratic National Convention. The document is drafted by the Rules and Affirmative Action Committees and is published for a 30-day public comment window – which is running now until April 29, after which, the Rules and Affirmative Action Committees will review all provided feedback and consider appropriate amendment. The State Central Committee will then consider and approve the plan as one of their primary items of business on May 6.

The document is lengthy, but it is also an important, foundational part of the work the Party does. It is worthwhile to bookmark it, and the [Party Documents Page](#), for future reference as we head into the 2024 election cycle.
