In Case You Missed It...

June Meeting Recap

The June meeting was our main endorsement meeting of the year. We got right to it after the usual opening formalities, and the Land Acknowledgement. Vice Chair **Rachel Glass** has been pointing members to ways to further honor the peoples on whose land we now live. June's request was that we consider making a donation to the American Indian College Fund at collegefund.org.

Approximately 175 people attended this virtual Zoom meeting, at which we voted via Zoom poll. A team of members worked behind the scenes in to make sure that the meeting proceeded as smoothly as possible. Carla Rogers controlled the technology while Leah Griffin and Chris Porter served as co-hosts; Ann Martin coordinated the speakers to make sure that they were ready to go when they were supposed to. Chris Porter ran the timer, a familiar role for him, whether at in-person meetings, or in virtual settings. Leah monitored the alternate voting, which was done via phone text. Hannah Cameron and Jordan Crawley over-saw the balloting and validated the tallies.

A short block of candidates was endorsed: Coreen Wilson and Joe Campagna for King County Superior Court positions, and John Wilson for King County Assessor. Subsequent offices were voted on separately, with Seattle Council District 1, King County Council District 8, and Burien City Council Position 4 having multiple candidates vying for our approval. Although it was on the agenda, no candidates stepped forward for Burien City Council Position 2.

Motions were made for dual endorsements in two races after no one on those first ballots achieved the 60% threshold. In speeches against Chris Porter made strong statements to dissuade members from giving the nod to more than one candidate, stating that we are a strong LD, and our endorsements mean a lot. In the end we voted not to endorse anyone in the race for King County District 8, or for Burien City Council Position 4. We may have an opportunity to revisit those races after the August 1st Primary.

King County Executive **Dow Constantine** made a motion to allow consideration for endorsement of **King County Proposition 1 – Veterans, Seniors, and Human Services Levy**. An 80% vote was required to change the agenda, and once that motion passed, we went on to endorse the levy renewal, which will be on the August Primary ballot.

Chair **Graham Murphy** encouraged us to sign the petition to be presented to the Burien City Council asking them to raise

the minimum wage in the city, which lags behind the minimum in other municipalities in the county. It is an issue that we supported with our endorsement of a resolution sponsored by the Transit Riders Union at our May meeting.

Hugo Garcia rose to acknowledge **Sili Savusa**, who is stepping down as Executive Director of the White Center Community Development Association at the end of August. She is leaving to lead the Pacific Islander Community Association of Washington. Hugo's brother and our former male alternate to the KCDCC, **Aaron Garcia**, will assume the role of interim director.

After discussion, Reyneveld, O' Halloran and Hamada received the 2/3 supermajority vote needed, and they are endorsed by KCDCC. Hollingsworth failed to meet that threshold, and is therefor not endorsed.

None of the above received the needed 2/3 vote in favor, so they are not endorsed by KCDCC.

There followed a discussion on suspending Rule 4, Section 3, which required an affirmative answer to the question "Are you a Democrat?" by a candidate in order to receive a KCDCC endorsement. The rule was suspended on a vote of 29-10. Then Jackie Bostock, seconded by Krystal Marx, moved that the membership endorse Cydney Moore for Burien City Council Position 2. On a vote of 33-4, Moore received the endorsement of KCDCC.

The hard work of Endorsements Chair Chaney and his Committee was acknowledged.

The meeting them moved to Good of the Order. Chair Barnes noted that the KCDCC fundraiser will be held on August 20th, and other members reported the dates of their upcoming events as well. We were reminded that ballots for the August primary election will drop on July 12th, and that in future years filing week will be moved to the first week of May.
